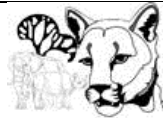

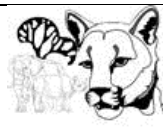

**Notice of Agreement:**

- This serves to inform you in case the insured deceased, Uviwe Funeral Services **will be responsible for the burial as agreed by the two parties**. All deductions of the funeral costs will be made from the amount received by the principal/beneficiary. Burial Society **funerals will ONLY be conducted either in the Western Cape & Eastern Cape**.
- **All members are to complete the membership application form. Beneficiary details are compulsory.**
- Uviwe Funeral Services **must be informed immediately** in an event a member is deceased so that the body can be removed. **If the body is removed by a different parlor, then the family is liable for all costs which will be charged by the parlor. This is applicable only if we will be conducting the service.**
- Death by Natural causes is six month(s) waiting period before a claim can be approved and 12 months waiting period for all new policy holders/dependents older than 74yrs.
- Suicide is twenty four (24) months waiting period.
- Accidental death has no waiting period; **however the policy will be active once we have made payments with the underwriter.**
- The Original or a Certified copy of the original death certificate of the Assured Life; proof of identity of the Assured Life; either the policy certificate, if available, or the application form; an official police report in the case of the death of the Assured Life due to unnatural causes; a medical report in the case of stillborn babies, indicating that the pregnancy reached the 26th (twenty-sixth) week; fully
- All monthly premiums are payable within no later than the date which the client has agreed/signed on the document (from 1st – 5th of every month).
- If you skip 1 (one) month's premium then you must **pay double** before the 5<sup>th</sup> of the following month and the policy will remain in force.
- If you skip 2 (two) months' premium the policy **will be cancelled**. You will then need to complete a new form and follow all processes followed by a new client.
- Nobody will be covered without a valid ID document, Passport or Asylum seekers permit , a Birth Certificate (children) or certified copies thereof
- Dependents added after the commencement of this policy will undergo the same Waiting Period. The Waiting Period will be calculated **after both the Joining Fee and the First monthly Premium is paid in full.**
- **Joining fee is R100.00 for all our Funeral Policy/Burial Society. It's advisable that you settle it with your 1<sup>st</sup> monthly premium so that your waiting period does not extend to 7 months.**
- **Premiums are subject to increase and formal communication will be forwarded at least 2-3 months prior the increase.**
- R250 administration fee will be deducted upon every cash claim.

## Claims Procedure

In the event of death, a Claim Notification Form must be completed at our offices and must be submitted together with the relevant supporting documents to the Underwriter within six (6) months from the date of death. Failure to do so within the six months will result in the benefit being forfeited.

Documents to be submitted for a claim

- This document or participation certificate and proof of premium payments.
- Fully completed Claim Notification Form
- Fully completed Police Report Form in cases of unnatural cause of death
- Proof of death: (BI-5) original or certified copy,(BI-12) original or certified copy of the Medical Certificate in respect of stiibirths only or (BI-20),
- Certified copy of the Principal Member's ID document
- Certified copy of the deceased's ID document or Birth Certificate in case of a child

Faxed copies must be clearly certified. The details of the Commissioner of oaths with all the relevant details must be clearly legible. Documents submitted other than those listed, will not be accepted. Affidavits are not accepted. The Underwriter reserves the right to request any further documents or information it may deem necessary to accurately assess a claim.

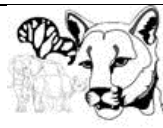
